- Deb shared enthusiasm at the success of Oregon Cultural Trust visit to WOW Hall on Monday March 6th
- Many connections were made and Deb will follow up on all the contacts made.
- It put the WOW Hall on the map as a historic, cultural hub in Eugene.
- CCPA is now a member of Travel Lane County Deb is making a presentation to staff on April 10th.
- Show are doing very well; 17 shows in March.
- Deb announced the First Annual Multicultural Dance Party to be held April 21st 8 pm to 12.
- Internal progress includes shows doing very well, photos being done for new website, brochure is being revamped

4. Financial Report – Deb Maher, ED

- Deb reported that the organization is very close to meeting annual revenue projection, although it is only 8 months into the fiscal year.
- Considering asking OCCU Foundation to sponsor some of our cultural offerings.
- Funding is potentially available at the state level, including lottery funds in addition to federal funds.
- Our cash position is very good. None of our accounts has more than \$250,000.
- Columbia Bank has been bought out by Umpqua Bank.
- We are evaluating a software program that searches for and sorts grants

Q. Sherry Franzen – What about applying to Spirit Mountain to help with roof replacement cost?

A. Deb – Yes, Spirit Mountain would fund 50%. We have applied. Likely cost is \$80,000 for roof and plaster repair. Need to find the other half.

Q/Comment. Thomas Hiura – Senator Manning would be a good person to contact about possible state financing.

A. Deb – Yes, I've been in touch with him. We are in Senator Prozanski's and Rep. Holvey's legislative districts.

Q/Comment. Sherry Franzen – Idea for birthday fundraising on social media. I intend to use my birthday to raise funds for the roof. Others could do the same. Need link to CCPA account for people to send donations.

Q/Comment. Ed Kashin – Building maintenance has been put off for a long time. Anything put into maintenance is an investment.

A. Deb – Yes, there is 40 years of deferred maintenance. For example, next month we will have a new phone VOIP system.
